

## \$5,000 cash insurance competition

## **Terms and Conditions**

- 1. The promoter is Summerland Credit Union ABN 23 087 650 806, AFSL 239238 101 Molesworth Street, Lismore, New South Wales 2480 (Promoter).
- 2. The prize is 1 x \$5,000 cash (Prize).
- 3. The offer is available from 1 March 2023 to 31 May 2023 (Promotional Period).
- 4. The Relevant States are New South Wales and Queensland.
- 5. Directors, officers, management, and employees (and their immediate families) of the Promoter; and the agencies, companies or participating premises associated with this competition are not eligible for the Promotion.
- 6. An Eligible Insurance Policy includes a new CGU:
  - a. Building Insurance Policy;

  - d. Be a resident of NSW and Queensland only

- 2. Policies purchased during the promotional period covering the same asset of a policy cancelled within the promotional period will not be eligible for the promotion.
